# Pledge of Allegiance:

Mayor Stephen Male opened the Council Meeting with the Pledge of Allegiance.

#### Oath of Office:

#### Roll Call:

## **Re-Organization of Council:**

Fire Chief Dean Parsons reported in December the fire company responded to 7 calls, spent 223 hours on drills and 146 hours on calls. He also reported that the fire station has been awarded a Northampton County grant of \$7,000 for the Labor Day celebration and all surge protectors have been installed in the fire station.

## Sanitation, Solid Waste & Recycling:

Council Members were given a copy of the Wastewater Treatment Plant December report.

Manager Zmoda reported in 2007 the Borough was awarded a grant of \$5.2 million to fund the expansion of the Wastewater Treatment Plant. Congress postponed the funding for several years. She received notification that this is now being considered for funding again. While the expansion of the plant is completed, the money is available only for a Wastewater Treatment Plant project and can be used incrementally. Zmoda stated that this year's funds were budgeted to have flow meters in areas that are suspected to have the largest inflow and infiltration issues. After the study is completed and a plan of action is determined, the grant money could be used to repair, clean out, and/or replace sewer lines. The project is to be funded 25% by the Borough and the federal cost share is 75%. The money will not be ready until 2025 and this provides time to get the study and plan completed.

Councilwoman Tammy Kemp made a motion to proceed with a letter of intent to Representative Susan Wild to utilize the grant money for improving the inflow and infiltration, seconded by Councilwoman Stephanie Cooper. Unanimous by roll call.

All Council Members received notification from Suburban Testing Labs of a rate increase.

#### <u>Finance, Tax Exoneration, Insurance & Personnel</u>:

All Council Members were given a copy of the Treasury Report as prepared and submitted by Borough Manager/Treasurer Zmoda. Councilwoman Josephine Hildebrandt made a motion to accept the Treasury Report, seconded by Councilwoman Tammy Kemp. Unanimous by roll call.
