Monday 14th of March 2022 - 3/14/2022 Council Meeting

Pen Argyl Borough Council held their Meeting for March on Monday, March 14, 2022

at 7:00 P. M. at Lookout Fire Hall Building.



Pledge of Allegiance:

Council President Joseph LeDonne opened the Council Meeting with the Pledge of Allegiance.

Roll Call:

Council Members present and responding to roll call: Joseph LeDonne, Tammy Kemp, Charles Kandl Jr., John Apgar, Scott Brumbaugh, Stephanie Cooper, and Josephine Hildabrant. Councilwoman Janell Connolly was absent.

Also present were Mayor Steven Male, Borough Solicitor Peter Layman, Borough Manager Robin Zmoda and Borough Secretary Juli Lemak.

Agenda Changes:

Councilwoman Tammy Kemp made a motion to approve the revised agenda, seconded by Councilman Scott Brumbaugh. Unanimous by roll call.

Visitors:

Ethan Habrial, 100 A Street, expressed his frustration with the permitting requirement for his solar panel permit application and handed an envelope containing documents for the zoning officer to Council President LeDonne. Solicitor Layman reminded him of the appeal process through the Council of Governments.

Tom Carlo, 301 S. Robinson Avenue, asked if the Borough sent correspondence to state legislatures regarding sludge application in Plainfield Township. Manager Zmoda advised him of a proposed resolution for tonight's meeting which requests state legislature to have more restrictive regulations on the biosolids spread on farmlands.

Carl Palmeri, representative of the non-profit group, Slate Belt Regional Skate Park Association (SBRSPA), informed Council members that they will present a proposal to the Park Board to donate a multi-use facility center for a skateboard park with obstacles, which may also be utilized with bicycles and walkers, etc.

Public Works Report:

All Council Members were given a copy of Public Works Director Steven Bender's February report to review.

All Council Members received a copy of the Park Board's Agenda from March 9, 2022 and February 9, 2022 meeting minutes.

Councilwoman Stephanie Cooper advised all Council Members that the Park Board's recommendation to fill the at-large vacancy is Steven A. Goffredo and also recommend Paige Edelman and Holly Larsen for the student vacancy.

Councilwoman Tammy Kemp made a motion to appoint Steven A. Goffredo to the at-large position on the Park Board, seconded by Councilwoman Josephine Hildabrant. Unanimous by roll call.

Councilwoman Tammy Kemp made a motion to appoint Holly Larsen and Paige Edelman as co-representatives for the student vacancy to the Park Board, and for the Park Board to determine at their next meeting who is the delegate and the alternate, seconded by Josephine Hildabrant. Council Members voting in favor of the motion were: Joseph LeDonne, Tammy Kemp, Scott Brumbaugh, Charles Kandl Jr., Josephine Hildabrant and John Apgar. Councilwoman Stephanie Cooper voted no. There being six (6) yes votes and one (1) no vote, the motion passed.

Councilman John Apgar made a motion to approve Concept #5 preliminary plan for E. Babbitt Avenue, as provided by Ron Madison of Collier's Engineering for \$41,262.00, seconded by Councilwoman Josephine Hildabrant. Council Members voting in favor of the motion were: Joseph LeDonne, Tammy Kemp, Scott Brumbaugh, Charles Kandl Jr., Josephine Hildabrant and John Apgar. Councilwoman Stephanie Cooper voted no. There being six (6) yes votes and one (1) no vote, the motion passed.

All Council Members received Pool Pals meeting minutes from February 7, 2022.

All Council Members were given a copy of Zoning/Codes Office's February report.

All Council Members received the Zoning Board's meeting minutes from

February 10, 2022 and the legal notice for the meeting on March 24, 2022.

All Council Members received a copy of a notification of completeness from the Northampton County Conservation District for the Pen Argyl High School for a new running track.

Manager Zmoda reported the Zoning Committee is creating a stand-alone ordinance for the registration of vacant properties and vacant store fronts. Also, the committee is reviewing the zoning code to potentially change the IL districts uses and the parking requirements for redevelopment from 2.5 to 2 parking spaces.

Police Report:

All Council Members were given a copy of the Slate Belt Regional Police Commission's meeting minutes from January 20, 2022 and February 1, 2022, January calls for service and the February 17, 2022 agenda.

Fire Chief's Report:

Fire Chief Parsons was present and reported the fire company responded to 5 calls for the month of February, spent 207 hours on calls and 196 hours on drills.

Councilman Charles Kandl Jr. made a motion to accept and approve Resolution NO. 2022- 3, as presented for the Borough as the update to the Borough's emergency operations plan, seconded by Councilwoman Tammy Kemp. Unanimous by roll call.

Solicitor Layman presented a memo explaining exemptions to the advertising and/or public auction requirements for personal property and limitations for transferring real property.

Councilman Charles Kandl Jr. made a motion to turn the Ford Grumman fire truck's title over to the fire company to sell, with the condition all proceeds will be transferred to the new truck fund, seconded by Councilman Scott Brumbaugh. Unanimous by roll call.

Councilman Charles Kandl Jr. made a motion to approve the Minutes for the Council Meeting of February 14, 2022, seconded by Councilman John Apgar. Unanimous by roll call.

Correspondence:

Councilman John Apgar made a motion to approve the scope of services for stormwater BMP and MS4 projects totaling \$9,000.00, as provided by Barry Isett & Associates, seconded by Councilman Charles Kandal Jr. Unanimous by roll call.

Councilman Charles Kandl Jr. made a motion to approve the purchase of twenty (20) snowflake holiday lights for \$8,860.00, using money donated from Slate Belt Rising, seconded by Councilman John Apgar. Unanimous by roll call.

Councilman John Apgar made a motion for the public works department to demolish the salt shed located at 298 S. Main Street, seconded by Charles Kandl Jr. Unanimous by roll call.

There being six (6) yes votes and one (1) no vote, the motion passed.
