Pen Argyl Borough Council held their Meeting for November on Tuesday, November 1, 2022

at 7:00 P. M. at Borough Social Hall.



Pledge of Allegiance:

Council President Joseph LeDonne opened the Council Meeting with the Pledge of Allegiance.

## Roll Call:

Council Members present and responding to roll call: Joseph LeDonne, Tammy Kemp, Charles Kandl Jr., John Apgar, Janell Connolly, Stephanie Cooper, and Josephine Hildabrant. Councilman Scott Brumbaugh attended remotely via phone.

Also present were Mayor Stephen Male, Borough Solicitor Peter Layman, Borough Manager Robin Zmoda and Borough Secretary Juli Lemak.

### Visitors:

Ethan Habrial, 100 A Street, quoted scripture, compared Council to Communists and stated there is no freedom in the Borough because Council follows the laws of the Borough Code and the Commonwealth of Pennsylvania. He went on to say, "if you do not like being called names then get off the darn Council."

Gerald Lennon, 361 Crestmont Street, Plainfield Township, expressed his concerns about extending Horizon Drive. Council President LeDonne informed him the Planning Commission recommended to Council the street is not be extended and will be voted upon later in the meeting.

Tom Carlo, 306 S. Robinson Avenue, asked if Council would write a letter to Plainfield Township opposing the expansion of Waste Management. No action was taken on this matter.

## Public Works Report:

All Council Members were given a copy of Public Works Director Steven Bender's October report.

Manager Zmoda informed all Council Members the concession stand upgrade at Weona Park will begin tomorrow. Also, the structures for the design of the playground have been chosen and a donation was received from the Woman's Club in memory of one of their members.

Councilwoman Tammy Kemp made a motion to approve the bill for the temporary fencing around the Community Center not to exceed \$5,000, seconded by Councilwoman Josephine Hildabrant. Unanimous by roll call.

Councilman Charles Kandl Jr. made a motion to close the center section of Weona Park to include the playground and pavilion for concession stand improvements, the reconstruction of the

playground, and demolition of the Community Center at Manager Zmoda and Public Works Director Steve Bender's discretion seconded by Councilwoman Stephanie Cooper. Unanimous by roll call.

Zoning Report:

All Council Members were given a copy of Zoning/Codes Office's October report and updated property maintenance log.

All Council Members received a review letter from the Lehigh Valley Planning Commission to modify parking requirements for certain uses, and conditionally allow existing buildings within the IL Light Industrial, Commercial District to be converted into apartments.

Councilwoman Tammy Kemp made a motion to advertise the zoning amendment to modify parking requirements for certain uses, and conditionally allow existing buildings within the IL Light Industrial, Commercial District to be converted into apartments, seconded by Councilwoman Stephanie Cooper. Unanimous by roll call. Councilman Charles Kandi Jr. made a motion to advertise the stormwater ordinance, seconded by Councilwoman Janell Connolly. Unanimous by roll call.

All Council Members received a special exception request letter from Victoria Doney,

312 N Robinson Avenue to allow her residence to be used as an Airbnb. The letter, along with her application, will be presented to Zoning at the next hearing.

# Police Report:

All Council Members were given a copy of Slate Belt Regional Police Commission's meeting minutes from September 15, 2022 and agenda from October 20, 2022.

Councilwoman Tammy Kemp made a motion to approve the resolution authorizing Manager Zmoda to apply for the Department of Community and Economic Development's Northampton/Lehigh County Local Share Grant application for \$57,080.00 for one (1) police vehicle for the Slate Belt Regional Police Department, seconded by Councilwoman Josephine Hildabrant. Unanimous by roll call.
